

### NOTES:

As of August 2019, 1505 communities in New York participate in the National Flood Insurance Program (NFIP).

Of these communities, 34 (or 2%) participate in the Community Rating System (CRS).

Of the top 50 New York communities (in terms of flood insurance policies-in-force), 9 participate in the CRS.

The remaining 41 communities present an outreach opportunity for encouraging participation in the CRS.

### Benefits of Joining the CRS

\* Activities credited by the CRS provide direct benefits to the community, including enhanced public safety, reduction in flood damage and environmental protection.

\* Residents are reminded that the community is working to protect them from flood losses.

\* Public information activities will build a knowledgeable constituency interested in supporting and improving flood protection measures.

\* Money stays in the community instead of being spent on insurance premiums.
